**16.01.22.1** Cllr Ward had spoken to Elin Tattersall at GRCC about the job of collating responses. She estimated that the likely cost of GRCC undertaking the work would be in the order of £500. The grant received for the GNDP should have been used for this but time had run out. Cllr Keyte needed to know what was included in the grant, itemised, and what was paid back. This would be needed before applying for another grant. There was, however, money included in the Precept and this could be used for paying GRCC.
