	<b>Resident 1</b> Wanted to raise a concern with the bus stop road markings that had recently been redon on Mallesor Road. He did not believe that the marking was in the correct place. Chair and Vice Chair advised that resident do the stop, and it is in the correct location.			
	He also voiced concerns about the new cycleway on Gotherington Lane. He was advised that the council and Vistry are aware of the issues and that Vistry are in the process of repairing them.			
	<b>Resident 2</b> Spoke to the council about the bin on Cheltenham Road by the shop – noting that it was not big enough for purpose and would the council consider a replacement.			
	<b>Resident 3</b> noted that Hayfeild had be issued with a formal warning due to the traffic incident that have occurred.			
	He also noted that the advertising sign for the new builds outside of the Village Hall had not been installed at the correct hight and that Hayfeild had been asked to rectify them.

I joined the Parish Council in July 2024, at a time when councillors were desperately needed, I held the desire to serve the residents and to have a positive impact on the village and its community.

What has transpired over the past 9 months is a targeting of the Chair by an individual, with the aim to criticise, obstruct and undermine the Chair's input to the Council, at whatever opportunity is presented to them. This is eroding any good modern working practices that should exist in the Council such as positive communication, collaboration, tolerance of weaknesses and appreciation of strengths. It takes the focus of our Councillors away from the work that needs doing, instead having to digest torrents of personal point scoring and attacks, which is tiresome.

On presentation of these observations to the individual concerned, their behaviour continues unapologetically and dismissively. The environment in which we are trying to work in continues to be toxic, and I no longer wish to be part of that.

With the applications currently being received for additional councillors, I feel now would be a suitable time for me to stand down from the role knowing a replacement will be forthcoming. Though, now with my "resident's hat" on, the increasing number of Village Hall Trustees who are wanting to also sit as Parish Councillors is a concern given that there is currently disagreement over ownership of the hall between the 2 parties. The same individuals making decisions on behalf of both parties is not in the best interests of the village, or the future of the Village Hall. I think this should be taken into account whilst the council considers those applications.

I wish you well in future endeavours, and I will be happy to attend future meetings sat on the other side of the table.
